



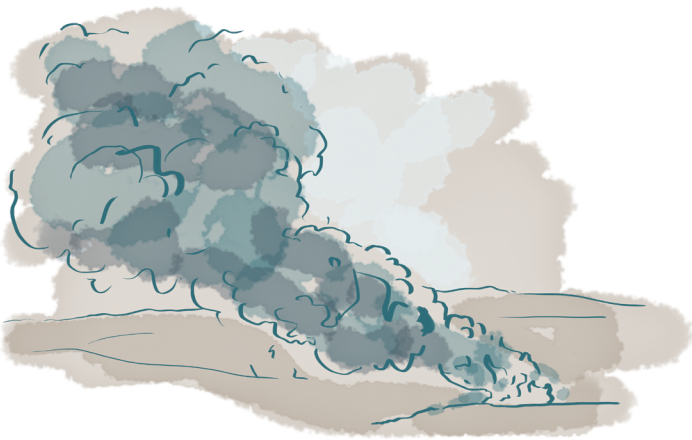
THREE-PHASE PLAN FOR ESTABLISHING THE

“HEALING OASIS AND TRAUMA CARE HEALING CENTER (NEVE TIKVA)”

“The Lord is my shepherd: I shall not want. He maketh me to lie down in green pastures: He leadeth me beside the still waters. He restoreth my soul.” Psalm 23 KJV

All of us need a Shepherd. All of us need THE Shepherd. As the trials and tolls of life in a fallen world compound and assail us, Yeshua longs to lead us to still waters, where He will restore our souls. This is true wherever we live, but it is especially true in Israel. A nation battered by history – ancient, modern, and recent – Israel is in need of healing.

NATIONAL TRAUMA AND HEALING THE INCURABLE WOUND



The recent events of the October 7th War, the 12 Days War, and the continuing conflicts have compounded a deep wound that already existed as the Israeli people have experienced a national trauma that has affected every single person living in Israel – Jew and Arab, secular and religious. According to a Feb. 11th, 2025, article from “The Times of Israel,” the State Comptroller’s office finds that approximately **3 million Israeli adults may suffer from some form of PTSD**, depression, or anxiety as a result of the October 7th war and ensuing conflicts. The need is clear, and we desire to be a part of the Lord’s answer.

HaTikva Project aims to provide a place of healing and refuge in Israel where the soul can be restored. We envision the establishment of a “Healing Oasis” with an atmosphere fine-tuned for healing, inclusive of on-site professional counseling programs, prayer, and worship, as well as facilitating follow-up care year-round. This healing oasis will be staffed by qualified trauma care professionals, counselors, and therapists dedicated to ministering to the hurting from all over Israel. Along with the high-level care, we will also minister to the souls of participants through interactions in peaceful, natural locations that

offer therapeutic outdoor activities.

Our existing week-long respite programs for soldiers in Italy have proven the effectiveness and need for expansion. Gleaning from the experience of those events in the past, we plan to launch a more robust one-week “healing oasis” program in Israel in the fall of 2025 as an additional proof of concept. HaTikva Project desires to mobilize resources from across Israel and around the world to establish a full-time, comprehensive trauma and healing center that will bring breakthrough to those in need of emotional, spiritual, and physical restoration. We pray this will be a place where the presence of the Lord dwells, and where He alone can heal the deep, seemingly incurable wounds in the hearts of His people.





A HEALING OASIS

A Healing Oasis is a mobile, repeatable, intensive trauma care retreat hosted at a rented vacation cottage compound that will be dedicated to serving those participating without outside distractions. The grounds will be intentionally staged to create a serene and peaceful healing atmosphere. Over the course of 5 to 10 days, participants will engage in a variety of trauma-informed care and recovery experiences, eventually including biblical counseling, prayer support, and outdoor therapeutic activities. Together with hired professionals and partner ministries, we will curate the experience carefully to serve both individuals and their spouses and families who join them.

PROPOSED ORGANIZATIONAL STRUCTURE:

Since its founding over 14 years ago, HaTikva Project has gained significant experience in launching new ministry initiatives in Israel, having pioneered a humanitarian aid ministry, a dental ministry, and an adoption

and foster care ministry. HaTikva Project will give leadership and initial oversight to establishing this concept. As the Healing Oasis and eventual Trauma Care and Healing Center is for the whole Body of Messiah, local congregations will be major stakeholders, and we envision local leaders having significant buy-in. HaTikva Project will provide leadership in vision casting, fundraising, strategic planning, and implementation.

BUILDING A COALITION OF MINISTRIES:

HaTikva Project is being joined by a local coalition of leaders from Israel's ministry and counseling communities, who seek to unite their unique expertise and strengths to contribute to the development of this project. This group of experts aims to bring together local congregations, therapy professionals, and ministry partners to collaborate on building a comprehensive, trauma-informed program. Our vision is to see a healing center that is rooted in biblical principles and community care, spearheaded by a locally led initiative that reflects the heart of the Lord and serves the people of Israel with excellence and compassion.

DEVELOPMENT PHASES

OUR PHASED APPROACH:

The Lord has planted the vision for a Healing Center in hearts for over 20 years. In the last 2 years, that vision has increased and crystallized, and we believe now is the time to take concrete steps forward. We propose a 3-phase plan:

PHASE 1 – Proof of “Healing Oasis” Concept *(Fall 2025)*

Plan and execute a roughly 1-week program that includes all elements of professional care, counseling, and prayer in a healing atmosphere (nature, agriculture, prayer rooms, etc.) with opportunity for ongoing care afterward through licensed professionals.

PHASE 2 – Regular “Healing Oasis” Programs *(2026-2027)*

Plan and execute multiple programs throughout the year. Increase the number of “Healing Oases” over time until the importance and value of finding a property for year round ministry becomes apparent.

PHASE 3 – Establish the Healing Center “Home” *(2028)*

Acquire a property to enable 24/7 availability for care and complete administration of the healing atmosphere (spiritually, design, agricultural, etc.). Healing Oasis Programs and many other programs developed in Phase 2 or later will move to this location.

PHASE ONE: HEALING OASIS PROOF OF CONCEPT

PROGRAM

A PhD-level psychologist will oversee the clinical care aspects of the program. Each person or family wishing to participate in the program will submit an application, including a clinical questionnaire. The counseling and therapy team would review the questionnaire and give recommendations on the appropriateness of the Healing Oasis weeklong program. If the applicant is a possible fit, they will be invited for a face-to-face interview with the lead counselor/therapist, who will have the authority to admit the individual. Once an individual is accepted, they will fill out the necessary forms and make a co-pay (a highly subsidized, minimal amount to ensure seriousness).

For Phase One, we would like to invite roughly 10 individuals and/or families to participate in the whole 5-10 day program, which includes lodging, meals, scheduled private appointments with licensed counselors, group therapy sessions, group activities, nature and agricultural activities, pampering, and more. Estimated cost for one participant = \$1500

STAFFING

Program Director with four main reports:

- Therapy Coordinator (developing the treatment programs, overseeing the counselors)
- Logistics and Scheduling Coordinator (facility requirements, meals, scheduling, etc.)
- Guest Experience & Children's Program Coordinator
- Prayer Coordinator (prayer room, general atmosphere, intercessory support)

In addition to the roles above, the Healing Oasis Program will require:

- Up to 5 counselors/therapists
- An Intercessory Prayer team
- A variety of worship leaders
- Food service provider
- Short-term volunteers could provide some support, such as intercessory prayer, kitchen staff, and room cleaning.

PHASE TWO: ONGOING HEALING PROGRAMS

PROGRAM

Expanding from Phase One to Phase Two would entail increasing to multiple programs each year. In 2026, our initial goal would be to do three programs and more the following year. Applicants would apply for acceptance in general instead of a specific set of program dates. After the counseling and therapy team interviews and approves the applicant, they would be put into the queue for one of the upcoming Healing Oasis programs. Each Healing Oasis program will have 8-12 individuals and/or families for a 5-10 day program, including lodging, meals, scheduled private appointments with licensed counselors, group therapy sessions, group activities, nature and agricultural activities, pampering, and more. During this phase, a greater emphasis will be placed on follow-up care and seeing individuals progress in their health and maintain their healing. Later in Phase Two, additional programs will be developed based on needs. Possible ideas are pastor rejuvenation programs, physical healing conferences, family therapy intensives, and even (porn, drug, etc.) addiction healing programs.

STAFFING

The HaTikva Project Program Director could transfer responsibility to another person at this point. The Therapy Coordinator will run our care programs and follow-up care outside of the 10-day programs. This position will require roughly 50% full-time. The Logistics Coordinator will likely remain an in-house HaTikva Project team member. The Prayer Coordinator's role will continue to be led by a volunteer.

PHASE THREE:

ESTABLISHING THE HEALING CENTER HOME

OVERVIEW

In Phase Three, HaTikva Project hopes to acquire a facility to house the developed healing programs permanently. This property will include the following services:

- Psychological care
- Therapy from licensed therapists
- Prayer and counseling from a Biblical/New Covenant perspective
- Group therapy
- Agricultural/Nature Therapy

**The team of therapists will update this list as the programs are developed.*

This permanent location will allow for broader services and more sustainable infrastructure, including outpatient therapy, short overnight stays, and longer programs. The treatment program's cost will be based on the various lengths of stay and therapeutic hours. Private care patients would pay discounted market rates, and applicants needing subsidized care would be required to pay only 20-30% of the price of the treatment.

FACILITY AND CAPACITY

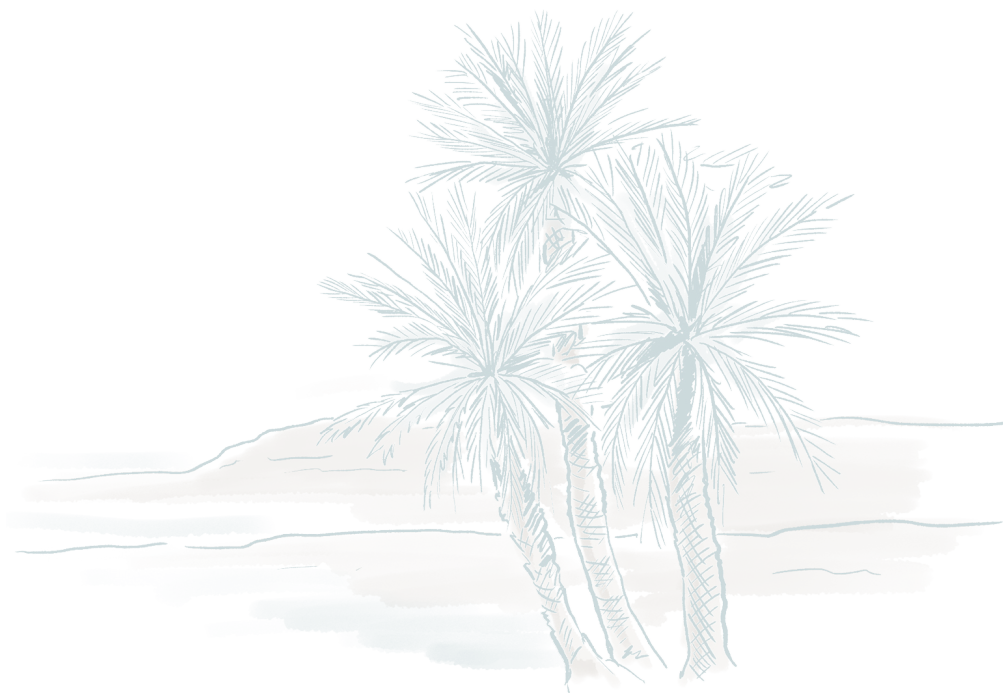
We envision a facility where at least 10 families or individuals can be housed and receive care concurrently. The ideal facility will offer separate, vacation cottage-style housing for program participants, including a bedroom, bathroom, and kitchenette. In addition to the cottages, the facility will need significant space for offices, meeting rooms, and a dining area. The ideal location will also provide ample outdoor space for therapeutic activities such as light agriculture/gardening, outdoor walks/hikes, etc.

STAFFING

- 1 full-time program director
- Up to 5 counselors/therapists
- 1 part-time logistics administrator
- 1 full-time facility manager/groundskeeper
- 1 full-time cleaning personnel
- 1 full-time food services staff

Detailed budget estimates for Phase 2 and Phase 3 will become available upon the completion of the previous phases to ensure accurate estimates.
